### Village of Reese Notice of Provisions of the Weed Ordinance

To: All owners, occupants or possessors of land in the Village of Reese.

Notice is herby given that in accordance with Chapter 10 of the Village of Reese Code of Ordinances all noxious, poisonous or injurious weeds or other weeds, grass, or brush exceeding a height of 6 inches upon any property in the Village of Reese shall be cut down, destroyed or removed, as the case may be, to prevent growth in excess of 6 inches. A violation of these provisions shall constitute a civil infraction, which may be treated as a municipal civil infraction and fees will be assessed according to the Village Schedule of fees.
