- **B.** Rohloff St. Reconstruction After project completion, a sink hole was found near Meridian. The area was excavated, repacked and asphalted. Shaw will be back to try a new process to merge the patch to the surrounding area to eliminate the seam.
- C. Community Park Brian Weihl addressed the council. The net sports court has been paved and fencing will be going up shortly. Striping will happen in the Spring. A grant for fencing around the basketball court was applied for. They are also moving forward on applying for the DNR Grant with Fleis and Vandenbrink.
